2-day clinic - participants must ride both days

- Day 1 - Groundwork & Noon Presentation
- Day 2 - More Groundwork, Flat Work OR Jumping
- Groups of 4 for 90 minutes each
- Limited (if any) stabling on-site; nearby stabling may be available. Contact Margie for more information and cost.
- Website will indicate when clinic is full and if private lessons become available.
- Private lessons may be available...please let us know if you are interested.

STRICTLY FOLLOWING PANDEMIC GUIDELINES

- Clinic riders are limited to themselves and 1 other person.
- Social distancing and masks required. Masks are optional when mounted.
- ***Auditors - only allowed if the clinic is held in the outdoor arena (weather permitting), indoor will be limited to Larkin Hill personnel, borders and clinic participants only.

Clinic Fees:

- Day 1 - Groundwork - \$150/rider
- Day 2 - More Groundwork or Flat Work - \$150/rider
- Day 2 - Jumping - \$160/rider
- Auditors*** - \$25/person per day (outdoor only, weather permitting)

No Refund after closing unless spot can be filled.

Cancellation due to the Pandemic, full refund minus \$25 to cover any expenses already incurred.

Clinic Rules:

- All horses must have proof of 12-month negative coggins (may be on file)
- All riders must wear a certified helmet with attached chinstrap at all times when mounted on the property
- Management reserves the right to refuse any application for any reason
