- All horses must have proof of 12-month negative coggins (may be on file)
- All riders must wear a certified helmet with attached chinstrap at all times when mounted on the property
- Anyone riding XC must wear a protective vest and medical arm band
- **Any e-mail entries will be liable for payment once schedule has been posted**
- All classes run generally under USEF/USDF/USEA rules
- "Clinic Attire" acceptable (neat and tidy)
- Judges will have a minimum of an "L" rating
- All arenas and warm-up on sand
- Jumping on grass (weather permitting)
- Extra jumping rounds may be added at the gate, but must be pre-entered once
- **NO add-on XC Rounds "at the gate" unless management says there is time**
- Management reserves the right to combine or split any classes due to number of entries
- Management reserves the right to refuse any entry for any reason
